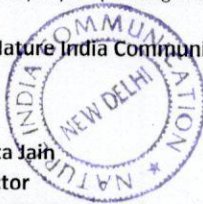


Review for the quarter ended as on 30th June, 2017
